WHY SHOULD I ENROLL?

Get health insurance that is:

AFFORDABLE

Inexpensive options for you and your family

COMPREHENSIVE

Free preventive services, hospital stays, prescriptions

FAIR

No denials or higher prices for pre-existing conditions

DISCOUNTED

If your annual household income is:

below \$45,960 for a family of 1

below \$62,040 for a family of 2

below \$78,120 for a family of 3

below \$94,200 for a family of 4

below \$110,280 for a family of 5

below \$126,360 for a family of 6

... you may be eligible for subsidies and tax credits.

HOW DO I ENROLL?

Starting October 1, you have two ways to enroll:

1. ONLINE

Go to HealthCare.gov to search for plans and enroll in insurance on the new marketplace.

Call **(800) 318-2596** to get help as you shop, compare, and apply for health insurance online.

2. IN PERSON

Call **(855) 899-6092** to find a local community organization near you where you can receive free, in-person assistance from a trained and certified Navigator.

Our Navigators can help you find out if you qualify for lower cost coverage, explain your choices, and choose the insurance plan that is best for you and your family. Navigators don't work for an insurance company—their only job is to help you.
